#### 1. Purpose

1.1 This policy outlines Aldar Education's approach to ensuring occupational health and safety excellence across its group. It provides a framework for managing risks and complying with regulatory obligations while fostering a proactive safety culture. Where schools fall under ADEK regulation, additional operational requirements are incorporated into local implementation.

#### 2 Scope

- 2.1 This policy applies to:
  - All Aldar Education-operated schools, training centres, and offices
  - All employees, students, parents, contractors, and visitors
  - All activities undertaken by the group that may impact health and safety

#### 3 Policy Objectives

- 3.1 Ensure the prevention of injury and ill health for all stakeholders
- 3.2 Promote wellbeing and a culture of shared safety responsibility
- 3.3 Ensure compliance with applicable laws, regulations, and codes of practice (e.g., OSHAD, ADEK, ISO 45001)
- 3.4 Provide adequate resources to manage and improve health and safety performance
- 3.5 Maintain a comprehensive management system that supports continuous improvement

#### 4 Management Commitment

- 4.1 Establish a robust occupational health and safety culture that is prominent throughout Aldar Education.
- 4.2 Ensure the company's commitment to occupational health and safety is driven by top level management.
- 4.3 Empower employees by providing suitable information, instruction and training to allow them to perform their roles safely.
- 4.4 Celebrate those employees who embody our occupational health and safety culture and philosophy and support all employees to make a positive contribution to a safer working environment.
- 4.5 Ensure that the occupational health and safety management system is continually improved.
- 4.6 Ensure that occupational health and safety performance is continually monitored and improved upon.
- 4.7 Implement and maintain a procedure for on-going hazard identification, risk assessment and the determination of necessary hierarchal controls.

- 4.8 Communicate and consult with employees and stakeholders on occupational health and safety matters.
- 4.9 Ensure that measurable health & safety related KPI's are established and continuously monitored and reported back to the Executive Leadership Team.

#### 5 Responsibilities

- 5.1 The Group-Level Responsibilities
- 5.2 **Chief Executive Officer (CEO):** Holds ultimate accountability for the health and safety of all Aldar Education entities. Ensures that sufficient resources are allocated to support this policy.
- 5.3 **Executive Leadership Team (ELT):** Supports the CEO in overseeing performance, allocating resources, and promoting a culture of safety.
- 5.4 **Chief Operating Officer (COO):** Approves the group OHS strategy and management plan, ensuring strategic alignment across business units.
- 5.5 **Group Head Operational Risk & Sustainability:** Develops and monitors the OHS strategy and compliance frameworks. Provides direct support to entities, including guidance on ADEK implementation.
- 5.6 School-Level Responsibilities (Including ADEK Compliance)
- 5.7 **Principals:** Responsible for local implementation of this policy. For ADEK-regulated schools, this includes:
- 5.8 Appointment of a qualified, full-time Health & Safety Officer (HSO) per ADEK Table 1
- 5.9 Operation of a licensed school clinic with a DoH-licensed school nurse
- 5.10 Conduct of annual emergency drills, risk assessments, and safety inspections
- 5.11 Compliance with bag weight limits, smoke-free campus regulations, and LPG restrictions
- 5.12 Display of this policy in both Arabic and English
- 5.13 Logging incidents via ADEK and ADPHC systems
- 5.14 **Operations & Support Services Managers (OSM):** Ensure fire/life safety systems are maintained, workplace inspections are conducted, and safety issues are addressed promptly.
- 5.15 **All Employees:** Have a responsibility to safeguard their own health and safety and that of others. They must comply with all relevant procedures, participate in training, and report hazards.
- 5.16 **Contractors and Service Providers:** Must adhere to Aldar and ADEK safety standards. Responsible for their own staff's compliance and safety performance.

#### 6 Risk Management

- 6.1 Aldar Education maintains a group-wide Occupational Health & Safety Management System aligned to OSHAD-SF and ISO 45001. This includes:
- Risk registers and hazard identification procedures
- · Risk assessments and hierarchy of control implementation
- Monitoring of key performance indicators and trends
- Internal and external audits

### Where schools are ADEK-regulated, risk management shall also cover:

- School transportation and traffic safety planning
- ADPHC electronic OSH platform reporting
- Formation of School Health & Safety Committees

#### 7. Health Services

- 7.1 ADEK-regulated schools must:
- Operate licensed on-site clinics with DoH-licensed school nurses
- · Maintain individual healthcare plans for students with additional needs
- Conduct health screenings (Grades 1, 5, 9) and immunisation programmes per DoH guidelines
- · Log all medical interventions and maintain secure health records
- Provide post-incident mental health support per ADEK policies

#### 8 Emergency Preparedness

#### 8.1 All Aldar Education entities must:

- Develop and test emergency plans, including evacuation drills
- Maintain fire detection and suppression systems (including HASSANTUK, where required)
- Establish clear communication protocols during emergencies

#### 9. Training and Awareness

- Ensure appropriate staff training in first aid, evacuation, and emergency respons9.1 All staff receive induction and refresher training based on their roles and risk profiles
- ADEK schools must educate students on PPE use, road safety, and emergency response
- Training needs shall be defined through risk assessments and aligned with ADPHC/DoH guidance

#### 10. Documentation and Review

- 10.1 Maintain digital records of incidents, inspections, and compliance activities
- ADEK schools must use the appropriate digital platforms for reporting (e.g., OSH system)
- This policy is reviewed annually or following significant changes

#### 11. Compliance Statement

11..1 All AE schools-regulated by ADEK are required to be fully compliant with the School Health & Safety Policy (v1.1) by February 2026. Failure to comply may result in regulatory penalties and enforcement action.
